# Dr. Bernard Cobetto Lecture Series: Former Secretary of Treasury to speak

The Dr. Bernard Cobetto Lecture Series will feature Paul H. O'Neill, former Secretary of the US Treasury. O'Neill will present "The Role of a Leader in Creating a Values-Based Institution" 7 p.m. Tuesday, April 13, in Ferguson Theater. This event is open to the public.



Chairman and CEO of Alcoa from 1987 to 1999, O'Neill

retired as chairman at the end of 2000. Prior to joining Alcoa, he was president of International Paper Company (1985-1987), where he was vice president (1977-1985). O'Neill worked as a computer systems analyst with the US Veterans Administration (1961-1966) and served on the staff of the US Office of Management and Budget (1967-1977). He also was deputy director of OMB (1974-1977).

He earned a bachelor's degree in economics from Fresno State College and a master's degree in public administration from Indiana University.

The Cobetto Lecture Series focuses on contemporary ethical issues. Established in 2005, it is made possible by the support of Dr. Bernard Cobetto and his wife, Ellen. Dr. Cobetto is a 1945 graduate of the College of Arts and Sciences at the University of Pittsburgh and a 1947 graduate of the University's Schools of Medicine. ▲

# **Pitt-Greensburg announces new Spanish major**

The University of Pittsburgh at Greensburg received approval in late January to establish an undergraduate major in Spanish within the Division of Humanities, leading to the Bachelor of Arts degree. Classes will be offered in fall 2010.

Because of the foresight and planning initiated by the faculty involved in developing the program, five Pitt-Greensburg students will graduate in December 2010 with the new degree. Dr. Nancy Estrada, associate professor of Spanish, Dr. Alicia Covarrubias, associate professor of Spanish, and Dr. J. Wesley Jamision, vice president of Academic Affairs, have led the process to develop the program.

The new Spanish major is expected to prepare students for careers, particularly in education and advanced degree studies. It also is intended to be part of an overall strategy for greater internationalization of the curriculum and to add signature programs that will attract students of increasing academic quality.

Spanish is spoken by more than 500 million people in 22 countries. Approximately half of the population of the Western Hemisphere speaks Spanish and there are 35.5 million Spanish speakers in the United States. Hispanics also are considered the largest minority in the United States.

The Spanish major will provide a balanced combination of courses designed to strengthen written and spoken language skills, to develop a solid background in history, society, and politics, and to emphasize literary and cultural heritage.

Students majoring in Spanish will be encouraged to study abroad. Pitt-Greensburg's long-standing exchange program with the Universidad de Guanajuato and the Pitt study programs in Spain will provide opportunities for this experience.

Winter Sports Wrap-Up:

he Pitt-Greensburg women's basketball team secured two postseason playoff spots, only to lose in the first round of both tournaments. In the Allegheny Mountain Collegiate Athletic Conference, the Lady Bobcats lost to Pitt-Bradford in the first round. The women were then eliminated in the first round of the ECAC South Region Tournament by St. Vincent College. The women ended the season 17-10 overall and 15-5 in conference play.

In addition to the team's success, seniors Kelsey Wilcox and Amanda Sheaffer have each posted individual record-breaking performances.

Scoring 1,000 career points as a junior, Wilcox continued to break Pitt-Greensburg school records for career rebounds and career points. Her current career totals stand at 1,586 points and 1,131 rebounds. She is the only player (male or female) here to record both 1,000 points and 1,000 rebounds.

Sheaffer is the seventh Lady Bobcat in school history to score 1,000 career points, posting 19 points in the 65-63 victory over Frostburg State University on February 17 that included a game-tying threepointer with 1:05 left in the game.

Head Coach Carol Gelet, the only Pitt-Greensburg coach to record 100 wins in a career, improved that record to 203 career victories this season.

#### Men's Basketball:

The Pitt-Greensburg men's basketball team secured the seventh seed in the AMCC post-season tournament with a 72-68 win over first-place Medaille College but lost in the first round to first-seed Pitt-Bradford. The loss capped an up-and-down season for the Bobcats who were 10-10 in conference play and 12-13 overall. The 2009-2010 season was Head Coach Jeremy Yetter's second year leading the team.

Senior Rashad Davison recorded the 1,000th point of his career at Pitt-Greensburg on January 2 in a loss at Penn State Behrend. Davison scored 10 points in the contest.

## Snow storms bring out the best in essential staff

Men's & women's basketball teams earn playoff spots

() perations at the University of Pittsburgh at Greensburg were minimally affected during the back-to-back storms that resulted in record-setting snowfalls and a state of emergency in Pennsylvania.

The campus closed Tuesday, February 9, through Thursday, February 11, because of hazardous road conditions and a request from the Westmoreland County Department of Public Safety for motorists to stay off the roads to allow for proper snow clearing.

Key personnel checked road conditions each morning during the

storms to assist in the decision-making process to close campus. Much credit goes to the departments that maintained essential staff during the closure, thus providing for the safety and wellbeing of Pitt-Greensburg residential students. These departments included Plant Maintenance, Residence Life, Chartwells Dining Service, and Safety and Security.

Homecoming and Family Weekend activities planned for Friday, February 5, proceeded as scheduled, and a special dinner held in Wagner Hall was well attended. Activities planned for Saturday, February 6, were postponed to Sunday, February 7.

Approximately 15 members of the plant maintenance department logged nearly 200 hours of overtime clearing snow from February 5 through February 18. Joe Olczak, director of the department, noted that everyone in his department is involved in snow maintenance, whether it's clearing sidewalks and entryways to buildings or using a snow plow, bobcat, snow blower or other

equipment to clear snow from parking lots and sidewalks.

For Rick Fogle, dean of students, and his staff, the safety and well-being of resident students is a primary concern-especially during a campus closure. Through the efforts of Fogle, Troy Ross, coordinator of housing and residence life, and Anthony Berich, director of athletics and recreation, students were able to use the facilities in Chambers Hall and speak with a staff member, if necessary. Resident assistants, students who manage sections of the residence halls, kept fellow students busy

with activities during the three days.

Richard McMahon, executive chef, and the Chartwells Dining Service staff catered the Homecoming Dinner Friday evening.

"Everybody has to report," McMahon explained. "It's okay to be late, but we ask our staff to make an effort to safely come into work." McMahon noted that regular hours were maintained at Wagner Dining Hall, the Bobcat Station, and the Coffeehouse. "Probably our biggest challenge was keeping everything stocked because the road conditions prevented students from leaving campus."

According to Tom Horan, director of Campus Safety and Security, his department worked the entire time the campus was closed. The officers worked well together in filling shifts other officers could not work, because they could not get in due to road conditions. The officers were also busy shoveling students out of their parking spaces and jumping car batteries that were dead.
